REGULAR MEETING November 8th, 2021 **DRAFT**

Supervisor Allen Dean called the meeting to order @ 7:00 p.m.

Public Comment— Ginger Chinavare came to the council asking about cemetery plots that were requested in July. Carlson explained the situation and will get back to the Chinavare's ASAP.

Richard Hall came to the council representing the Area Clean-up committee. He is suggesting Newkirk and Ellsworth Townships look into the piece of property in the Village that was donated to the townships years ago to use for the cleanup instead of Mainstreet/Village Hall. Suggesting there is a fence put up around the property and we could use 40-yard dumpsters instead of garbage trucks, which would in turn possibly turn Area cleanup to be held over the course of two weekends. Newkirk Township and Township Assessor Linda Monroe is currently looking for the deed to the property. Further discussion is needed.

Cemetery- Roger Peel came to the meeting to help the council with the cemeteries. In 2010 Roger created a computer program for all three cemeteries. Carlson will meet with Roger this month to learn about the program and get everything caught up. Roger Peel is very helpful with this and all his work is very appreciated.

Fire Department- Minutes were presented.

Area Clean-up- Nothing

Roads- LCRC sent the Local Road Brine Agreement for 2022. The council received a copy of the brine map and will discuss the roads that need brined next months meeting.

Old Business - The Valley Cemetery sign was received and is up!

Greenman went to a meeting about Gypsy Moths this month. To get your land treated for Gypsy Moths the cost is about \$30-\$50 per acre. The council decided to have Treasurer Pendley to put information in the winter tax newsletter for the residents to make a personal decision about it.

New Business- Resolution 21-11-1 Bank Signatories was presented to the council. It was brought to the councils attention the need to remove Sharon Baker from the bank signatory, leaving Brittany Carlson, Allen Dean, Kim Pendley and Deputy Treasurer Crystal Jurik.
