## Regular Meeting Minutes May 8<sup>th</sup>, 2023 DRAFT

Chachulski made a motion to pay the bills, 2<sup>nd</sup> by Pendley – Roll Call Vote- Yes- Pendley, Chachulski, Carlson, Greenman, Dean. –No- None. All in Favor. Motion Carried.

Library-Financials and Minutes Presented. Director Amy Shank has been traveling around to all the municipalities the library serves just to stay in contact and get to know each other a bit. The library meetings are the second Thursday of each month at 4:30pm.
