Motion carried.

Bills-OCD Accounting \$90.00; Double J Lawncare \$285.00; Amazon \$141.60; LCRC \$9,192.04; Lake County Treasurer \$27.47; Cadillac News \$84.60; Chachulski made a motion to pay the bills, 2nd by Greenman –Roll Call Vote- Yes- Pendley, Chachulski, Carlson, Greenman, Dean. –No- None. All in Favor. Motion Carried. Pendley motioned to adopt Ellsworth Township expenditure approval & post audit policy. 2nd by Carlson. –Roll Call Vote- Yes- Pendley, Chachulski, Greenman, Carlson, Dean –No- None. All in favor. Resolution adopted.

Cemetery- The council is looking into a steel arch to go over Pleasant Hill Cemetery entrance. As well as something to better distinguish Valley Cemetery.
