The Summer Real Estate Tax notice is payable beginning July 1, 2025. To avoid any penalties/interest, please pay by September 15, 2025. Please allow ample time when mailing your tax payment. If your payment is late and the paid receipt shows a balance however small, please do not ignore it. Any balance showing represents unpaid Real Estate Property Tax. As a reminder, I will accept partial/monthly payments during any current tax cycle. Please make checks payable to: Ellsworth Township Treasurer and mail payment to 8391 E. 4 ½ Mile Rd., Luther, MI 49656. I also have a drop box at this address. Taxes may also be dropped off at the Luther Lake Osceola State Bank. If paying cash or need to see me, please call to set up an appointment. If there is no answer, please leave a message. Information to pay by Credit/Debit Card is in the upper right-hand corner of your Tax Bill. I will hold special office hours on September 15, 2025, from 9:00 am to 5:00 pm. Interest is charged on all summer payments received after September 15th. Interest is charged as follows: September 16, 2025 @ 1%, October 1, 2025 @ 2%, November 1, 2025 @ 3%, December 1, 2025 @ 4%, January 1, 2026 @ 5%, February 1, 2026 @ 6%.
