Increase Audit \$2,600.00 from \$8,600.00 to \$11,200.00 Carlson motioned to accept the budget amendment as presented, 2nd by Chachulski. –Roll Call Vote- Yes- Chachulski, Bacon, Carlson, Pendley, Charles –No- None. All in favor. Motion carried.
